| 1. A-1, while moving, catches the ball with his/her right foot on the floor. A-1 jumps and alights on both feet simultaneously. Prior to beginning a dribble, A-1 lifts the right foot off the floor and then releases the ball to start the dribble. The official rules a legal start of a dribble. Is the official correct? | 1. | Yes | No |
| 2. During a throw-in, A-2 catches the ball while airborne. A-2 lands simultaneously on both feet. The right foot lands on the division line and the other foot in the frontcourt. The official rules a backcourt violation. Is the official correct? | 2. | Yes | No |
| 3. Thrower-in A-1 passes the ball to A-2. A-2 catches the ball and passes it back to A-1 who has one foot touching inbounds and the other foot in the air over the boundary line. The official rules A-1 is out of bounds. Is the official correct? | 3. | Yes | No |
| 4. As the lead official bounces the ball to A-1 for his/her first free throw and before A-1 catches it, B-1 steps into the lane and requests a time-out. The official grants the request. Is the official correct? | 4. | Yes | No |
| 5. Jumper A-1 taps the ball which hits the tossing official. Jumper A-1 then catches it. The official rules a jump ball violation. Is the official correct? | 5. | Yes | No |
| 6. A-1’s throw-in is caught by B-2, who has one foot on the sideline. The official rules a violation on B-2 and awards team A the ball out of bounds at the spot where B-2 caught the ball. Is the official correct? | 6. | Yes | No |
| 7. A-1, in the frontcourt, passes the ball to A-2, who is in the frontcourt. A-2 muffs the ball and the ball hits an official who is standing on the division line. The ball rebounds back to A-2, who catches it without the ball touching the floor. The official rules a backcourt violation on team A. Is the official correct? | 7. | Yes | No |
| 8. During a jump ball, jumper A-1 taps the ball to A-2, who is airborne from the frontcourt. A-2 catches the ball and, before landing, throws it to A-3 in the backcourt. The official rules a legal play. Is the official correct? | 8. | Yes | No |
| 9. B-1 fouls A-1, team A is in the bonus. The official erroneously awards team A the ball out of bounds. A-1 commits a throw-in violation. B-1 is awarded the ball out of bounds. While team B has the ball at his/her disposal, the official is informed that team A is in the bonus. The official awards A-1 the one and one and following the free throws awards team B the ball out of bounds. Is the official correct? | 9. | Yes | No |
| 10. A-1, who has completed his/her dribble, passes to A-2. A-2 unable to catch the ball, taps it back toward A-1. A-1 recovers the ball and starts a new dribble. The official rules this a double dribble. Is the official correct? | 10. | Yes | No |
| 11. Following a score by team B, A-1 throws the ball along the end line to A-2. A-1 then steps inbounds. A-1 steps back out of bounds and receives a return pass from A-2, then passes the ball inbounds to A-3. The sequence takes place in less than 5 seconds. The official rules a legal play. Is the official correct? | 11. | Yes | No |
| 12. Team A submits its team members and starting lineup at least 10 minutes before the game. After the 10 minute mark, the coach adds two names to the squad list and team A is assessed a technical foul. During the first time-out the officials are notified that two team A players are wearing different numbers than those listed in the official scorebook. The official charges another technical foul to team A. Is the official correct? | 12. | Yes | No |
| 13. With the score tied, A-1’s try is touched by B-1 on its upward flight when the signal sounds indicating time has expired in the game. The ball enters the basket. The official disallows the basket. Is the official correct? | 13. | Yes | No |
| 14. Coach of team A is charged with an indirect technical foul. The official instructs the scorer that the foul counts as a team foul to reach the bonus. Is the official correct? | 14. | Yes | No |
| 15. The ball is loose on the floor while team A is in control. A-1 commits a common foul on B-2. Team B is in the bonus. The official rules a team control foul. Is the official correct? | 15. | Yes | No |
| 16. Before the bonus is in effect and while the ball is in flight during a field goal attempt by A-1, A-2 fouls B-2. The try is successful. The official rules team B’s throw-in is a designated spot throw-in. Is the official correct? | 16. | Yes | No |
| 17. A-1, while chasing the ball during his/her interrupted dribble, steps on the boundary line. The official rules A-1 has committed an out of bounds violation and awards the ball to team B. Is the official correct? | 17. | Yes | No |
| 18. While the ball is out of bounds and at the disposal of team B, B-1 commits an intentional personal foul. The official rules a team control foul. Is the official correct? | 18. | Yes | No |
| 19. While A-1’s try is in flight, the official rules a double personal foul. A-1’s try is successful. The official counts the goal and resumes play by awarding the ball to team B. Is the official correct? | 19. | Yes | No |
| 20. While B-1 is holding the ball for a throw-in, there is player control and team control. Is this correct? | 20. | Yes | No |
| 21. After the official hands the ball to A-1 for an out of bounds throw-in, a double personal foul is charged. The official awards the ball back to team A. Is the official correct? | 21. | Yes | No |

22. Yes No 22. A-1, while airborne, taps a pass to the floor, returns to the floor, catches the ball and then starts a dribble. The official rules this a double dribble. Is the official correct?
23. Yes No 23. A-1 is bleeding and the official stops play and directs A-1 to the bench. Team A has no 60 second time-outs remaining but has one 30 second time-out. The coach wants to use the 30 second time-out to keep A-1 in the game. The official rules a 30 second time-out may not be used to keep A-1 in the game. Is the official correct?
24. Yes No 24. Team A is granted a time-out. As A-1 is heading to the bench area, A-1 is charged with a technical foul. The official rules A-1 is bench personnel and charges an indirect technical foul to the head coach. Is the official correct?
25. Yes No 25. During a throw-in by team A on the frontcourt endline, A-2 is in the free throw lane for 3 seconds. The official rules a 3 second violation. Is the official correct?
26. Yes No 26. Thrower-in A-1, places the ball through the boundary line. B-1 fouls A-1. The official rules this an intentional personal foul. Is the official correct?
27. Yes No 27. A-1, while airborne, catches a pass and throws the ball to the floor. A-1 returns to the floor, catches the ball and then starts a dribble. The official rules a legal play. Is the official correct?
28. Yes No 28. During an alternating possession throw-in by team A, a double personal foul is charged. The official charges the fouls and awards the ball back to team A and rules this is still an alternating possession throw-in. Is the official correct?
29. Yes No 29. Following a time-out, free thrower A-1 delays entering the semi-circle. The official charges A-1 with technical foul. Is the official correct?
30. Yes No 30. Following a successful field goal, team B has the ball out of bounds for a throw-in when A-1 near the end line commits a common foul on B-2 prior to the bonus. The official allows team B to move along the end line. Is the official correct?
31. Yes No 31. Thrower-in A-1 fouls B-1. The official rules a player control foul. Is the official correct?
32. Yes No 32. Prior to A-1 releasing the ball on a free throw, B-2 enters the lane followed by A-2. Both are in a marked lane space. A-1's free throw is unsuccessful. The official penalizes only B-2's violation and awards A-1 a substitute free throw. Is the official correct?
33. Yes No 33. Thrower-in A-1, from the frontcourt endline, throws the ball into the backcourt. A-2 is the first to touch the ball in backcourt. The official rules a backcourt violation. Is the official correct?
34. Yes No 34. A-1's pass is deflected by A-2 and enters the basket from below. The ball is clearly above the ring. The official rules a violation on team A. Is the official correct?
35. Yes No 35. A-1 dives for a loose ball and slides on the floor. Prior to momentum ending, A-1 rolls over on to his/her back. A-1 then sits up. The official rules a legal play. Is the official correct?
36. Yes No 36. After the horn has sounded to start the second half, team B is on the floor ready to play. Team A continues to huddle. The official uses the resumption of play procedure to resume play. Is the official correct?
37. Yes No 37. One official rules a block and the other official rules a foul on the airborne shooter. The ball enters the basket. The officials rule a double personal foul, disallow the basket and use the alternating possession procedure to resume play. Is the official correct?
38. Yes No 38. Prior to the first free throw by A-1, Team A chooses not to occupy the second marked lane space. B-2, who is occupying third marked lane space requests permission to occupy the second marked lane space. The official allows B-2 to occupy that space. Is the official correct?
39. Yes No 39. Team A's school colors are red and green, A-1 enters the game wearing a red arm compression sleeve. A-2 has a green arm compression sleeve. The official rules team A's players are in compliance with the rule. Is the official correct?
40. Yes No 40. The possession arrow favors team B to start the second quarter. Prior to the ball becoming live a technical foul is charged to team A. Following the free throws, team B inbounds the ball and a held ball occurs. The official awards the throw-in to team A under the alternating possession procedure. Is the official correct?
41. Yes No 41. During A-1's interrupted dribble, A-1 runs several steps past the ball then returns to get the ball. When A-1 returns to the ball, the ball is motionless on the floor. A-1 hits the ball with his/her hand to give the ball motion. The official rules a double dribble. Is the official correct?
42. Yes No 42. Team A requests and is granted an excessive time-out and is charged with a technical foul. Following the free throws, the official informs the coach that play will resume immediately and team A is not entitled to the full 60 second time-out. Is the official correct?
43. Yes No 43. A-1 is charged with his/her second technical foul. After the official notifies the coach that A-1 is disqualified, A-1 directs profanity toward the official. The official charges A-1 with another technical foul and an indirect technical foul to the head coach. Is the official correct?
44. Yes No 44. A-1's try rebounds off the backboard and is batted back toward the division line by A-2. A-3, while airborne from the frontcourt, catches the ball and lands in backcourt. The official rules a backcourt violation. Is the official correct?

45. With three-tenths of a second remaining in the game, A-1's throw-in is caught by A-2, who is fouled as he/she throws the ball toward his/her basket. The foul occurs before the signal sounds indicating time has expired. Team A is in the bonus. The official awards A-2 a one and one. Is the official correct? 45. Yes No
46. Thrower-in A-1 rolls the ball up the floor in backcourt. As soon as the ball touches the floor in the backcourt the official starts the 10 second violation count. Is the official correct? 46. Yes No
47. During A-1's interrupted dribble, a double personal foul is committed. The official awards the ball to team A. Is the official correct? 47. Yes No
48. When the official is ready to place the ball at A-1's disposal for the throw-in, he/she notices team A has six players on the floor. The official assesses team A with a technical foul. Is the official correct? 48. Yes No
49. While B-1 has the ball for a throw-in following a field goal by team A, team A is issued a warning for breaking the plane of the boundary line. The official rules that team B's throw-in is a designated spot throw-in. Is the official correct? 49. Yes No
50. A-1's pass from A's backcourt hits a teammate who is in the frontcourt. The ball rebounds into the backcourt and is first touched by A-1. The official rules this is not a backcourt violation because there was no player control in the frontcourt. Is the official correct? 50. Yes No
51. During A-1's free throw and before it ends, A2, in a marked lane space, loses his/her balance and makes contact with his/her hand in the lane. The official rules making contact with any part of the court outside a marked lane space is a violation. Is the official correct? 51. Yes No
52. The coach of team A confers with the official to try to prevent or rectify a correctable error. The official informs the coach that he/she is wrong. Team A has no 60 second time-out remaining but has one 30 second time-out remaining. The official charges team A with the 30 second time-out. Is the official correct? 52. Yes No
53. While A-1's free throw is in flight on a one and one, A-2 and B-2 commit a double personal foul. A-1 's free throw fails to hit the ring resulting in a violation. The official uses the alternating possession procedure to resume play. Is the official correct? 53. Yes No
54. While the ball is at the disposal of A-1 for a free throw, A-2 fouls B-2. Team B is in the bonus. The official rules a team control foul. Is the official correct? 54. Yes No
55. To start the second half, the possession arrow favors team B. Prior to the start of the second half team A is assessed a technical foul. Following the free throws, team B inbounds the ball and a held ball occurs. The official resumes play by awarding the throw-in to team B. 55. Yes No
56. During an alternating possession throw-in, A-1 places the ball through the plane of the boundary line. B-1 grabs the ball and a held ball is ruled. The official awards the ball to team B ruling that when the ball was touched while over the line, the alternating possession procedure ended. Is the official correct? 56. Yes No
57. Team A is charged with a technical foul. B-6 replaces B-1 to attempt the free throws. Following the attempts and while B-2 has the ball for the throw-in the timer erroneously starts the clock and it runs for two seconds. The official sounds the whistle to stop the clock. The official directs the clock operator to put the consumed time back on the clock. B-1 reports to replace B-6. The official beckons B-1 to enter. Is the official correct? 57. Yes No
58. Dribbler A-1 dribbles the ball off of B-1's foot causing A-1 to lose control. When A-1 gets to the ball, A-1 catches the ball and begins to dribble. The official rules a legal play. Is the official correct? 58. Yes No
59. Team B is issued a warning for interfering with the ball following a goal. Later in the game, team B commits a violation by breaking the plane of the boundary line before the ball is released. The official rules there is no penalty because the violations were for different situations. Is the official correct? 59. Yes No
60. A-1 is fouled and erroneously awarded the ball out of bounds. A-1 inbounds the ball to A-2, who is immediately tied up by B-2 resulting in a held ball. The possession arrow favors team B. The lane is cleared and A-1 is awarded his/her one and one and play is resumed with an alternating possession throw-in by team B. Is the official correct? 60. Yes No
61. During an alternating possession throw-in by team A, A-1's throw-in is caught by both A-2 and B-2 causing a held ball. The official rules the possession arrow is to be turned and awards the ball to team B. Is the official correct? 61. Yes No
62. A-1's throw-in is deflected by B-2. Prior to either team gaining control inbounds, A-2 fouls B-2. Team B is in the bonus. The official rules a team control foul. Is the official correct? 62. Yes No
63. While A-1 has the ball for a free throw, B-1 in a marked lane space fakes entering the lane. A-1 commits a free throw violation by not hitting the ring. The official rules a fake causing an opponent to violate only applies to players in a marked lane space and treats this as a double free throw violation. Is the official correct? 63. Yes No
64. While team A has the ball out of bounds for throw-in, A-2 commits a common foul on B-2. The official rules a team control foul. Is the official correct? 64. Yes No
65. A double personal foul is committed in the low post while A-1 is dribbling near the division line. The official awards the ball back to team A nearest to where the ball was located. Is the official correct? 65. Yes No

66. Yes No 66. A-1's pass is deflected by B-1. The ball enters the net from below and is in the net below the ring when A-1, touches the ball and net. The official rules a violation on team A. Is the official correct?
67. Yes No 67. A-1, while dribbling in the frontcourt, has the ball batted away and the ball rolls into the backcourt. The official begins the 10 second count when the ball touches the floor in backcourt. Is the official correct?
68. Yes No 68. While the ball is at the disposal of A-1 for a throw-in, A-2 and B-2 commit a double personal foul. The official resumes play by awarding the ball back to team A. Is the official correct?
69. Yes No 69. Prior to A-1 releasing the ball on his/her free throw, B-1 steps into the lane. The official inadvertently sounds the whistle. The official re-administers the free throw which is unsuccessful. The official allows play to continue. Is the official correct?
70. Yes No 70. A-1 and B-1 collide and both players are bleeding. The official stops the game and directs both players to the bench. Team A requests and is granted a time-out. Following the time-out both players enter the court ready to play. The official allows both players to resume playing. Is the official correct?
71. Yes No 71. A-1 is fouled while in the act of shooting and awarded two free throws. The first free throw is missed and the official allows the ball to remain in play. B-1 rebounds the ball and then commits a violation. The official now recognizes A-1 should have been given another free throw. The official awards A-1 his/her second free throw with no players on the lane lines and play shall resume from the point of interruption. Is the official correct?
72. Yes No 72. Team A is awarded the ball to start the second half. Team A commits a throw-in violation. The official instructs the scorer to turn the possession arrow toward team B's basket and awards team B the ball. Team B commits a throw-in violation. The official awards the ball to team A and has the scorer turn the arrow toward team A's basket. Is the official correct?
73. Yes No 73. A-1 is at the free throw line to attempt a free throw. As A-1 starts the motion to release the ball, team B bench as a unit stands up and stamps their feet and shouts miss it. A-1's try is unsuccessful. The team A coach wants team B's team members charged with disconcertion. The official rules only the players on the floor can disconcert. Is the official correct?
74. Yes No 74. Just as the official is tossing the ball for a jump ball, B-1 commits a violation. A-1 then taunts B-1 and is charged with a technical foul. Following the free throws, team B is awarded the ball for a throw-in at the division line opposite the scorers table. When the official places the ball at the disposal of team B, the official directs the scorer to set the arrow toward team A's basket. Is the official correct?
75. Yes No 75. A-1 is fouled with 5 tenths of a second on the game clock and the score tied. A-1 makes the first of a one and one. Team B requests and is granted a time-out. Following the time-out team B places four players in the marked lane spaces. As A-1 releases the ball attempting to miss the free throw, all four players step into the lane committing a lane violation. A-1's attempt is unsuccessful. The official awards A-1 a substitute free throw. During the substitute free throw, team B again violates and A-1 deliberately misses the free throw. The referee notifies the team B coach that the next time his/her team commits a lane violation his/her team will be charged with a technical foul. Is the official correct?
